1. I, \_\_\_\_\_, hereafter referred to as the adopter, hereby agree that the above described Pit Bull is being adopted by me solely as a pet for myself and/or my immediate family, and will not be used for any illegal activity, including fighting.
2. Ownership of the Pit Bull is reserved to and vested in Underdogs SA Rehabilitation Centre at all times, but the risk of the said Pit Bull shall immediately pass to the adopter.
3. I hereby agree that I will not sell, give away or otherwise dispose of said Pit Bull to any person(s), dealer, retailer, auction, institute or any other organisation for any reason. The adopter shall also not dispose of the Pit Bull by gift, sale or any other means, without first obtaining the written consent from Underdogs SA Rehabilitation Centre. If, at a later date, I am unable or unwilling to keep this Pit Bull, I undertake to return said Pit Bull to the care of Underdogs SA Rescue and Rehabilitation Centre. Failure to comply with this clause will result in legal action.
4. I hereby agree to care for the above described Pit Bull in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care. I further agree that said Pit Bull shall reside inside my home and shall not be allowed to roam freely. I also undertake not to chain the Pit Bull and to ensure that he/she receives the necessary annual veterinary vaccinations.
5. I hereby agree that this pet shall wear a collar or harness with identification tags at all times.

6. I hereby agree that Underdogs SA Rescue and Rehabilitation Centre has the right to inspect my premises from time to time to ensure that the terms of this agreement are met.

In the event that Underdogs SA Rescue and Rehabilitation Centre's authorized representative, after inspecting the premises, and in his / her sole and absolute discretion is satisfied that the terms and conditions of this agreement are not being properly adhered to, then Underdogs SA Rescue and Rehabilitation Centre shall be entitled to claim repossession of the Pit Bull immediately and the adopter shall have no claim of whatsoever nature against Underdogs SA Rehabilitation Centre rising out of such repossession and all monies paid by the adopter in respect of this agreement shall be forfeited.

7. I hereby agree that Underdogs SA Rescue and Rehabilitation Centre will have the right to remove the adopted Pit Bull at any given time if the pet is not being taken care of in an acceptable manner.

8. I hereby agree that the **adoption fee of R1450.00** covers the cost of the 1<sup>st</sup> vaccinations, deworming, sterilization and microchip. This amount has to be paid prior to collection of the Pit Bull. No Pit Bull will be released without confirmation that payment has been received and that the stated amount appears on Underdogs SA Rescue and Rehabilitation Centre's bank statement.

9. The adopter hereby acknowledges having received the Pit Bull from Underdogs SA Rescue and Rehabilitation Centre in an acceptable condition.

10. The adopter hereby confirms that he / she has not been accused or convicted of cruelty and / or neglect of any animals in the past.
